Numbers following each reading refer to *Hansard* pages where the text of debates is found; dates for each reading are in brackets following the page numbers. Bills numbered 200 or higher are Private Members' Public Bills. Bills with lower numbers are Government Bills. Bills numbered Pr1, etc., are Private Bills.
